3.0 Organisation Information

3.1 Description of the certification unit

Ladang Sungei Bilut Sdn Bhd comprising two main estates area addressed as Ladang Sungei Bilut and Mil Plantation, a freehold land with total size of 344.47 ha at Raub District in Pahang, Malaysia. The headquarters of company is in Klang Selangor.

List of estate under Ladang Sungei Bilut Sdn Bhd. are Ladang Sungei Bilut Sdn Bhd, Mil Plantation Sdn Bhd and Bilut Development Sdn Bhd

Ladang Sungei Bilut and Bilut Development has shared the MPOB license as refer to License No. 501390102000 (expiry date: 31/3/2010), while Mil Plantation obtained their MPOB License as refer to License No:b 501789302000 and will expire on 31/8/2020

The system had been established since June 2018 with formation of policies had been officially released to address written statement on the commitment towards the sustainable production, signed on 1st Jun 2019; signed by Mr Lim Kum Loke

The sets of procedure are also established and they're having a uniform system in compliance with MSPO requirements.

3.2 Description of the supply base (including planting profile)

Ladang Sungei Bilut and group of estate management had planted oil palm for Ladang Sungei Bilut (270.95 ha), Mil Plantation (64.14 ha) and Bilut Development (9.38 ha). It was noted that 7.39 ha of the occupied land was not planted with oil palm due to unsuitable land conditions. Their FFB are being delivered to Raub Oil Mill Sdn Bhd with contract agreement-is valid until until 31/8/20:


3.6. Maps of Company Location, Plantations and Organised Smallholders

4.0 Certification Assessment

4.1 Stage 1 Audit

- The Stage 1 audit was conducted on 13 to 114 Nov 2019
- The objective of the Stage 1 was to assess the readiness of the documentation established and implemented in accordance to MSPO 2530-3:2013 Part 3 (General Principal for Oil Palm Plantations and Organized Smallholders)
- According to the Certification Scheme, an initial due-diligence audit for operators which are entering into the MSPO system, and which do not have any certification or those having management system certification e.g. ISO, COP.
- These organizations shall undergo both Stage I and II audits
- The audit team has applied the Malaysian Sustainable Palm Oil Part 3
- The Stage I audit was conducted with covering the following activities:
 - Review of documentation for compliance to relevant P & C requirements for plantation
 - Reporting of issues concern during Stage I audit
 - Address key areas for observation during onsite assessment

4.1.1. Stage 2 – Certification audit:

- The Stage 2 audit was conducted on 1 to 2 Dec-19 by 2 auditors.
- The objective of the Stage 2 was to assess the documentation established and implemented in accordance to MSPO 2530-3:2013 Part 3 (General Principal for Oil Palm Plantations and Organized Smallholders)
- According to the Certification Scheme, an initial due-diligence audit for operators which are entering into the MSPO system, and which do not have any certification or those having management system certification e.g. ISO, COP.

- Common process in the estate are harvesting, manuring and spraying activity. However, there is only harvesting process being audited and other activities were not running during 2nd Stage audit.
